Dolsa maintains that it is an «honor» to be responsible for not going ahead with the Grifols project

The members of Units per Ordino point out that there are issues in the country that «are not accepted».

The councilor of the minority in the Municipality of Ordino, Enric Dolsa, emphasized last Tuesday during the press conference following the ordinary session of the Parish Council that «it is an honor that the head of government mentions me personally in the matter de Grifols», establishing a clarification for wanting to close «definitively» the issue with Catalan pharmaceuticals; thus attributing himself as one of the main responsible for the multinational not entering the Principality. In this sense, Dolsa affirmed that he knew firsthand, from close people to the healthcare company, that the project would not continue, even if Espot maintained the implementation of the agreement.

The councilor maintained that during a meeting in Sant Cugat it was specified that if the appeal went to Strasbourg, it could not be carried out given the international situation, let

alone if it were lost because it would be «a terrible joke» for all parties. Moreover, Dolsa reported that during the meetings by video conference the situation was seen positively, since it seemed that this appeal would not enter, despite this being «a wrong calculation given that June 18th was not the last deadline, but the day 20th», sending this finally on the 19th by himself. On the background of the project, Dolsa wanted to reply to the head of government to remind him that there are certain issues in large foreign companies that «cannot be admitted» here.

«For us, who have fought against Grifols since the national elections, it is a great victory», confirmed the councilor of the minority of the Municipality of Ordino, Jordina Bringué, adding that they will continue to defend the non-entry of the multinationals into the country, but if through other alternatives that can create a foreign investment that is «regulated and controlled», replied the minister in response to the decision taken.

The president of Andorra Endavant, Carine Montaner, also spoke last Tuesday about the non-implementation of the pact:

«The fact that the Grifols project is not being done, for Andorra Endavant, is excellent news considering that the membership agreement signed was unacceptable». «There were many things

that were shaky in this contract signed between Govern and Grifols, especially in the confidential part in English», explained Montaner. For this reason, the president of AE asked Batllia for the annulment of the Members' Pact in the name of a non-affiliated General Counsel.

Continuing on this topic, Montaner exclaimed that «it was funny» that the Government asked the opposition to self-criticize when they had signed a contract with many irregularities and with the «gift of a piece of land with little excavation to be done for 25 years valued at more than 14 million euros and 200,000 euros every year for 25 years», she emphasized. Shortly after learning of the rejection of the project, AE asked the Government to recover the land to carry out public-private projects for affordable housing and a multi-service residence for the elderly, as well as other projects to give quality of life to citizens at a «reasonable» price, specified Montaner.

Finally, the president of the Social Democratic Party, Pere Baró, also communicated in a press conference the «lack of transparency of the Government» headed by Xavier Espot and his plan «among friends» that has led to the non-agreement with Grifols. Thus, Baró read in his speech that the only thing his party

has done in the Grifols matter has been to «position itself with a project in which we believe», not in the Grifols company itself, but in the economic diversification that the country is looking for, he commented.

«it will have to go further» so that it does not remain too short. For her part, and on the same point, the president of Andorra Endavant, Carine Montaner, also reflected last Tuesday on the matter stressing that «we will not be able to vote on the law, we will simply participate in the improvement of the text, but we will not ratify in any way», she specified, in the event that the mandatory transfer regarding empty flats is preserved, since it is seen from Andorra Endavant as «excessive interventionism», which will have an adverse effect on the law on the property, she pointed out.

this project has fallen on «the lack of transparency» which forced them to ask for the information that had not been given to them by the Government, without moving them «the difficulties he went through», and with the doubts he generated seeing them as a business. ●
