The public exhibition of the Ordino POUP closes with 220 allegations

The exhibition of the Ordino parish planning plan was closed this Wednesday, after being made public for three months, since December 7th, in the Buna room in Ordino. In this period, also open to complaints, a total of 220 tickets have been received, which will now have to be analy-

zed. The drafting and legal team will start making the revisions immediately, to study different cases, some of collective interest, and the vast majority coming from particular cases.

«The high number of allegations shows the interest of the citizens, and as we have already progressed, this will lead to a review and certainly the modification of the text. Our obligation is to respond to all these concerns. A job that we will do with all the care and rigor it requires», assessed the Consul Major, Maria del Mar Coma, after closing the exhibition and evaluating the number of

comments received.

With regard to the updated data of the exhibition held, 196 prearranged visits have been attended. On February 9th, a consultative day was organized by town, where 126 residents attended. Unlike the towns of Cortinada, whose meeting had to be moved to the following Friday, Llorts and El Serrat, where the residents of the parish established an open and participatory debate, the Ordino meeting was attended by more technical profiles with more specific queries.

the Municipality, have been addressed to all citizens, who have been informed by all the communication channels available to the corporation, as they highlighted.

However, the majority of inquiries have been made by owners with land affected by the change in classification and qualification of the land, which involves the change from developable to non-developable. From the Municipalities, we want to show «maximum transparency and collaboration» to respond to the different cases and find consensus in all cases that the law allows.» ●

Ferran Costa withdraws the charges against Carine Montaner

The AE leader considers it good news for the country's image

Ferran Costa has withdrawn the charges and the civil lawsuit he brought against Carine Montaner. He made this known last night through a statement, in which he indicated that «the mediation of the general trustee has pushed me to make the decision since I have no intention of receiving anything from Ms. Montaner». Likewise, he commented that he resorted to justice «as a lever available to any citizen when he sees his rights violated» and that he is now «satisfied» with the provisional qualification of the Attorney General, who mentions that «he sees signs of crime» in the actions of the current leader of Andorra Endavant.

On the other hand, Costa also pointed out in the letter that given the statements that Montaner has made over the last four years, «I have no interest in serving as an excuse to feed this media circus full of malice, of which some they get so many spurious incomes», while assuring that from his point of view the lawsuit served «to objectify the grievance she has infringed on my person».

In addition, he wanted to emphasize that, «unlike what has been made to be understood», only the five presidents of the parliamentary groups unanimously decided to make transparent and publish all salaries. «This measure, in my opinion, had to be used to show that it was all the full-time general councilors (nine in total, including Mrs. Montaner) who were charged an additional item, according to the regulations of the General Council», he concluded.

EL PERIÒDIC was later able to speak with Carine Montaner, who explained that she considers it a right decision and good news for the image of the country, and added that «this matter has gone too far», emphasizing that «I am not his enemy» and that what she wanted to do was «rescue him» and not «sink him». «If Mr. If Costa had read my interview with EL PERIÒDIC on June 15th, 2020, he would have seen that my will was not to go against him at all», explained the politician, asser-

ting that «I did not go to sink anyone but I celebrate the transparency of the Liberal group». Finally, the leader of Andorra Endavant indicated that, however, «you must know that the case continues and is in the hands of the prosecutor, who has made some very harsh conclusions (it must be remembered that there were two years of conditional prison and two of disqualification, in addition to compensation) and we will have to see what happens because the issue will take a long time». ●
