Andorra needs an update in accessibility

The Principality must adapt to the new needs and demands of the population

he Constitution of the Principality of Andorra recognizes the dignity and equality of all people, and guarantees their rights, in addition to prohibiting any kind of discrimination.

So, the accessibility law that was presented in 1995 recognizes people with any type of disability who may have the conditions so that the equality and freedom of all those people who present a disability are effective.

hairs or for blind people who wear canes». The technician also explains that during his day-to-day work he comes across many pedestrian crossings that are not adapted, and even disabled parking spaces next to trees or on a sidewalk.

Xavier Fernández explains that «as there are no criteria in public bodies, everyone uses the criteria they want.

The three protagonists have also explained that they have never received any subsidy from the Government for their disability, only in the case of Xavier Fernández, who was a Paralympic athlete: «if you want to be an athlete, the Government subsidizes you a part». So, both Toni and Xavier Fernández, as well as Alexia Vallés, have had problems in their day-today lives with accessibility due to their disability.

people? Do people with visual, hearing and motor disabilities have difficulties in their day-to-day life? Toni Fernández is a musician and has been blind since he was from eye cancer and now wears prosthetics. He explains that urban planning from the Government and the Municipality of Escaldes - the parish where he has lived since he was a child - is not accessible, and even less now with the works on his house. Fernández also explains that although he knows some routes to get to places, he cannot get where he wants, since not all traffic lights in the country are accessible.

On the other hand, Alexia Vallés is hearing impaired, due to an autoimmune disease that causes her to gradually lose her hearing. Alexia explains that one of the biggest problems on a daily basis is going to the doctor: «normally they don't lower their masks as per protocol,

re normally because «I couldn't read the lips of the dependents. More than once I have taken my bank card and spent it without knowing how much I was being charged.»

Finally, Xavier Fernández has reduced mobility, and has been in a wheelchair for 33 years. He is an emergency operator technician, that is to say, he manages them. He finds that in some works there are certain shortcomings, for example in Meritxell Avenue «it is not accessible for people who wear wheelc-

A new edition of the «Vall del Madriu» conference cycle begins

his year, the second edition of the «Madriu-Perafita-Claror Valley, Heritage of Humanity, Heritage of all» series of conferences has been scheduled, after the good response that the first edition received last year. This cycle of conferences aims to bring the Valley and its values closer to all citizens of the country, with the aim of dealing with all kinds of topics related to both its natural and cultural heritage.

The first of these conferences will start next March 15th, with the name «A walk through the forests of the Valley, past, present and future». This is an informative talk about the evolution of the role and ecosystem services of the forests of the Madriu-Perfafita-Claror Valley, where through a journey through time we hope to improve the understanding of the forests and the challenges that they will become Marc Font, forest engineer from Andorra Research + Innovation, will be in charge of the talk. who want to attend the conference «The fauna of the VMadriu-Perafita-Claror Valley» will meet. In this talk, some of the species present in the valley will be presented, in addition to talking about their origin and implementation, the links with their biotopes, their particularities and the possibilities we have of meeting them. In this case, the speaker of the talk will be Marc Mossoll, biologist, mountain guide and member of the Grouse Specialist Group of the IUCN (International Union for Conservation of Nature).

On May 10th, the conference «Steelwork in the Madriu-Perafita-Claror Valley» will explain the impact that steelmaking activity had on the valley and on the shaping of its landscape, as well as the evolution of the works of rehabilitation that is being carried out at Farga del Madriu. Oliver Codina, historian of the Department of Cultural Heritage of the Government of Andorra, will coordinate this talk. Finally, on May 24th, the conference «Huts and lands of the Madriu Valley» will be held. In it, the historian David Mas will explain the past of the valley through the hut type constructions that can be found in the Madriu Valley, both isolated and forming a piece of land. A type of witness to the process of colonization of the valley by humans, as well as their type and location, their uses and the approximate time they were built.

All conferences will take place at 7:00 p.m. in the municipal hall of Escaldes-Engordany, except for the one on May 24th, which will take place on the 3rd floor of the Escaldes-Engordany Art Center (CAEE). They will last approximately one hour and will be completely free.

UNESCO WORLD HERITAGE SITE // The Madriu-Perafita-Claror Valley was declared a World Heritage Site in 2004, in the cultural landscape category. Located in the southeast of the Principality of Andorra, it extends through the parishes of Andorra la Vella, Escaldes-Engordany, Encamp and Sant Julià de Lòria.

This valley is the most important secondary river basin in the country and is 12 km from end to end, with an elevation difference of 1,855 meters. Its highest point is Pic de la Portelleta (2,905 m) and through the whole valley it is possible to make a large number of excursions, where you can see its rather strange or endangered animal and plant species.

In addition, in the summer you can spend a night in any of the five shelters offered by the entire Valley or practice your sports activities: horse riding, climbing, hunting, fishing and, in the winter season, snowshoeing and skiing mountain, among others. ≡
